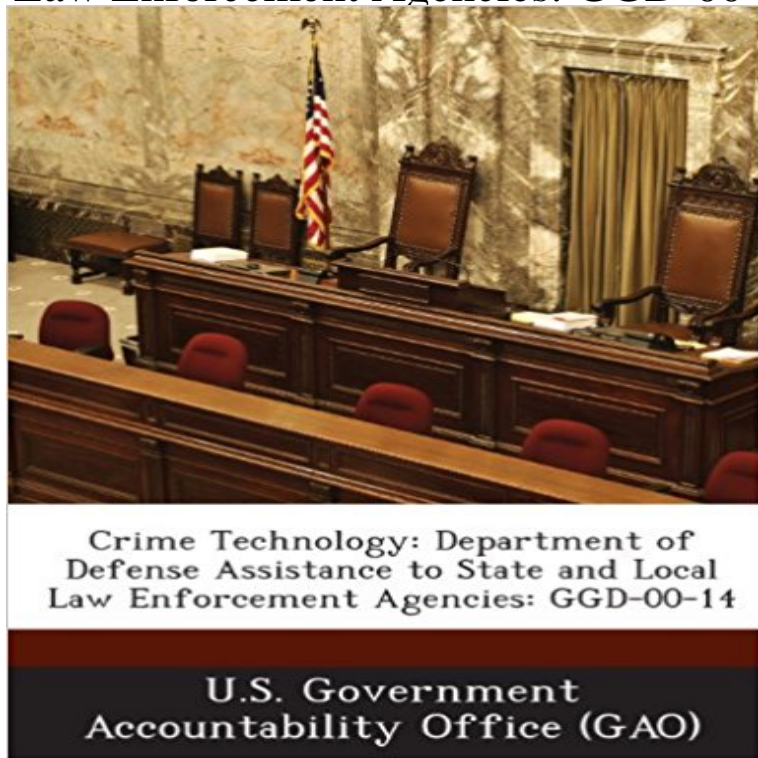


Crime Technology: Department of Defense Assistance to State and Local Law Enforcement Agencies: GGD-00-14
